Re:- Proposed Water Charges For Mt. Larcom Residents

Dear Sir.

We believe that the maximum price of \$8.69/ Kilolitre proposed by the QCA for water delivered to Mt Larcom residents is based on flawed estimates of real costs.

Consider the facts:-

- (1). QCL, not GAWB, paid for the water main from Yarwun. The real cost of water beyond Yarwun should therefore exclude this capital cost.
- (2). Maintenance and depreciation costs for the main and any infrastructure from Yarwun onwards should be proportionately no higher than those in any other region under GAWB jurisdiction. Real water charges at Mt Larcom must reflect this.
- (3). Our current access fee already pays for the infrastructure costs that are common to each and every user of reticulated water drawn from the Awonga dam. Real water charges at Mt Larcom must reflect this.
- (4). The real cost of water at Mt Larcom should therefore be the cost of water at Gladstone plus pumping costs from Gladstone to Mt Larcom. The proposed charge of \$8.69/Kl in no way reflects this cost.

If the proposed water charge is implemented, the effect on the entire community will be devastating. Property values in Mt Larcom will plunge and growth of the town will cease or become negative. We will be forced to revert to tank water and extension of this practice throughout the community will result in the GAWB being left with an expensive white elephant. Is this the outcome you are seeking? We suggest that an unbiased, knowledgeable, competent, independent authority be appointed to determine a fair and equitable price for water delivered to Mt Larcom residents.
