The Queensland Competition Authority has accepted Aurizon Network's 2023-24 regulatory asset base (RAB) roll-forward application, as set out in the attachment to this letter.

It is satisfied that the roll-forward is based on the principles of clause 1.1 of schedule E of the 2017 access undertaking (UT5), having regard to its February 2024 decision on the GAPE and Newlands pricing DAAU.
